I have acted as a mediator for close to twenty cases. I did not keep track of those but I have been involved in trade chamber movement for the last thirty years and have mediated disputes between members of the chamber on ad hoc basis and on a pro bono basis. Among the disputes I have successfully mediated are trading disputes, when there have been a claim for liquidated damages for delay in shipment, issues of quality for cashew nut shipment, an issue of quality for pepper shipment, an issue of price adjustment due to delay in delivery for cloves and similar cases. I have also mediated family disputes in Australia as all members of the family trusted me and another estate matter in India. These disputes mediations were on an adhoc and confidential basis; I did not keep documents.

I am on the panel of mediators for small claims tribunal in the State courts and have also been appointed as a co-mediator by SMC. I am also a Specialist Mediator at SIMC.
